COVID19 Participation Waiver

I acknowledge the contagious nature of Coronavirus/COVID19 and that the CDC and public health authorities are recommending social distancing. I attest that:

- I am not experiencing any symptoms of illness such as cough, shortness of breath or difficulty breathing, fever, chills, repeated shaking with chills, muscle pain, headache, sore throat, or new loss of taste or smell.
- I have not traveled internationally within the last 14 days. I have not traveled to a highly impacted area, or a Non-Phase 2 county, within the U.S. in the last 14 days.
- I reside in an Oregon county in phase 2.
- I do not believe that I have been exposed to anyone with a suspected and/or confirmed case of the Coronavirus/COVID19 in the last 14 days
- I have not been diagnosed with Coronavirus/COVID19 and not-yet cleared as non-contagious by State or local public health authorities.
- I am following all CDC recommended guidelines as much as possible and limiting my exposure to the Coronavirus/COVID19.
- I will abide by all verbal and written instructions given to me by The Rink Exchange and EugeneFSC and their employees.

I hereby release and agree to hold The Rink Exchange and EugeneFSC harmless from, and waive on behalf of myself, my heirs and any personal representatives, any and all causes of action, claims, demands, damages, costs, expenses and compensation for damage or loss to myself and/or property that may be caused by an act, or failure to act of The Rink Exchange and EugeneFSC, or may otherwise arise in any way in connection with any services received from The Rink Exchange and EugeneFSC. I understand that this release discharges The Rink Exchange and EugeneFSC from any liability or claim that I, my heirs, or any personal representatives, may have against the ice skating facility with respect to any bodily injury, illness, death, medical treatment, or property damage that may arise from, or in connection to, any services received from The Rink Exchange or EugeneFSC. This liability waiver extends to the ice skating facility together with all parties involved with managing and directing The Rink Exchange.
