- o Frozen 5K- Christy has medals and is working on bibs and forms with Uplink Spyder.
- o Testing on freestyle sessions- We can add time to freestyle sessions for testing. Who will pay for this? What are the minimum and maximum skaters? Are we willing to pay for this if we have no skaters? We need to look at the OSC calendar- maybe pick a date in January. Christy will look into this. Denise is going to message coaches.
- o Columbia Bank-new terminal and QR code option- Sticking with square, paypal, and stripe. It would be \$16 per month to have an account for the terminal, and it isn't worth it.
